Red River Valley Gymnastics Credit Card Policy

Red River Valley Gymnastics now requires a debit/credit card to be kept on file when registering for classes.

What this means to you is: You must supply a credit/debit card when registering for a class at Red River Valley Gymnastics. The debit/credit card will be kept on file. You may pay your tuition via cash, check or credit card by the 15th of the each month. If your payment has not been received, your credit/debit card will be charged for any remaining balance on the 16th. If your card has expired or is declined and payment is not received by the 25th you will receive a \$10 late fee. If payment has not been received by the end of the month your child will be dropped from their class unless prior arrangement has been made. **The debit/credit card on file is used only as a backup.**

- Late fees will only apply if your debit/credit card is declined or has expired and there is a balance on the account after the 25th of the month.
- Red River Valley Gymnastics will only send out statement to accounts that have a balance after the 25th of each month.
- Your debit/credit card will continue to be billed until we receive a 2 week paid drop notice.
- If you participate in auto pay we will not need a debit/credit card back up.

By signing below I understand that my debit/credit card will only be billed if I have not paid my account by the 15th of each month. I also understand that in order to drop a class I must submit a 2 week paid drop notice.

The registration is for the entire season (September through August) I understand that I must give a **2 week written & paid notice** at the office if I wish to withdraw from class

_____ I am aware that Red River Valley Gymnastics has auto pay. At this time I am declining auto pay. I understand that I must have a debit/credit card on file and if I have not paid my account by the 15th of each month Red River Valley Gymnastics will charge the debit/credit card I have on file.

_____Once registered, your class selection is reserved from month to month until you formally, in writing, withdraw your child from class. Your class selection cannot be taken by another student until you request a change in time, level, or until you choose to withdraw from the class with a two week written notice. You may request a class change at anytime, as space permits.

_____In order to withdraw from a class, you must complete a **DROP form** (available at the front desk) or notify the Club in writing that your child will no longer be participating. You are responsible for class fees through your two week written notice. Notification must be received by the Club no later than two weeks prior to the withdrawal. Failure to notify the Club of an impending withdrawal will result in you being responsible for all of the class fees due.

_____Parents are not allowed on the gym floor. (Except when you are participating in a parent and child class.) If you have a question for your child or you have concerns with something happening on the floor please stop at the front desk and let the office staff know and they will relay the message onto the coach.
